

Information sheet: National visa

Visa for skilled workers holding a university degree

(Section 18b (1) Residence Act)

Basic information

- Documents not in the German/ English language must be submitted with a certified German translation. A translation of the personal data page of the passport is not required.
- All documents must be presented as original, certificates must be presented with apostille/legalisation. Your original documents will be returned to you once your application has been processed.
- **Processing time is approx. 4-8 weeks** but can take longer in individual cases.
- Flight reservations are not required to apply for a visa – please book your flights only when you have received your visa.
- The Embassy reserves the right to request further documents.
- Missing documentation delays the procedure and can result in your application being rejected.
- **Please do not contact the Embassy to check the status of your application during the normal processing period.** Such inquiries are extremely time-consuming for the visa section and can thus not be answered.

General information

As *a skilled worker with an academic qualification recognised in Germany*, you can be issued with a residence permit to engage in *skilled employment* that your qualification enables you to perform.

Visa application checklist

The following documents are to be submitted in full with every application also in the case of persons travelling together (e.g. spouses or children).

Where applicable, two (2) declarations fully completed and signed regarding contact details and power of attorney	
Two (2) recent biometric passport photos (see specimen photos)	
Valid and personally signed passport with at least two (2) completely empty pages	
Two (2) uncertified copies of the data page of your valid passport	
Completed form signed by your employer: Declaration of employment (original with two (2) copies)	
From the age of 45: Proof of adequate provision for old age (original and two (2) copies (only if salary does not amount to at least 55% of the annual contribution assessment ceiling for the general pension insurance scheme – 2020: 45,540 € gross/per annum))	
Proof of qualification: University qualification (all pages, original and two (2) copies)

<p>Proof of adequate health insurance cover</p> <p>If as an employee you are subject to mandatory statutory health insurance, you must bear in mind that this insurance can only begin when you take up residence in Germany and enter into employment. If you enter Germany beforehand, private health insurance must be taken out for the period prior to</p>	

	employment beginning and prior to being eligible for statutory health insurance. In its terms and conditions, travel health insurance can exclude protection if a long-term or permanent stay is planned. So-called incoming travel insurance can also contain such exclusions.
